

# THE GOVERNMENT UNEMPLOYMENT ASSISTANCE FOR COVID-19 (GOV-UEA - TOURISM PACKAGE)



# **INFORMATION SHEET**

The Government of The Bahamas, in collaboration with the National Insurance Board (NIB), is responding to bring financial support to self-employed Bahamians in the tourism sector whose income sources have been disrupted by COVID-19.

While the programme will be administered by the National Insurance Board, it is outside of the NIB package of benefits; it is not an earned entitlement; does not require the satisfying of National Insurance contribution conditions; and does not require Department of Labour involvement.

#### Who Qualifies for the *COVID-19-Related* Unemployment Assistance (GOV-UEA)?

- Self-employed Bahamians, working directly in the tourism industry who are not employed in any other capacity and without any other streams of income from employment.
- Persons claiming the assistance must prove that they are self-employed in the tourism sector by presenting at least one of the following supporting documents wherever relevant and/or applicable:
  - ✓ business license:
  - ✓ letter from hotel allowing you to work from their property;
  - ✓ relevant association membership letter;
  - ✓ straw market permit;
  - ✓ business receipts which show purchases related to your business; or
  - ✓ any other documentation which can show that you work in the tourism sector as a selfemployed person.

# Who Does Not Qualify for COVID-19-Related Unemployment Assistance?

- ✓ Employed persons (NIB's Unemployment Benefit may apply);
- Entrepreneurs and business owners in the tourism sector (i.e. persons who employ other persons). These persons will be captured under other Government programmes;
- Persons who stopped work prior to the onset of the COVID-19 crisis in The Bahamas (March 13, 2020).

## What options are in place for self-employed persons who have not paid NIB

✓ This is not an NIB benefit and, therefore, there are no (N.I.) Contribution conditions to satisfy.

# Do I have to register with NIB?

- ✓ Yes. Self-employed persons must be currently registered with NIB;
- ✓ If you are not registered, you will be registered at the time of the application.

#### How much money will I receive?

\$200 per week for a maximum of 8 weeks (as long as you remain unemployed).

## How will the payments be issued?

- ✓ Direct payment to bank accounts (preferred method);
- Cheques (highly discouraged).
  (NIB is striving to have this payment made in as short a time as possible. Processing time will vary depending on the completeness of the application and supporting documents.)

## All applicants must sign a Declaration Statement indicating the following:

- ✓ Applicants are not being paid by an employer at the time of application.
- Applicants must inform NIB if there are any changes in their circumstances which may affect their entitlement to payment.
- Acknowledge that it is an offence to provide false information or to withhold information to qualify for this payment.

# How do I submit my application?
